Ltd. of 30 Pasir Panjang Road Mapletree Business City #17-31/32 Singapore 117440 ("Samsung").</p> <p>The Contest is conducted in conjunction with the Samsung Odyssey Cup Dota 2 Championship 2024: Dota 2 Tournament ("Tournament") is scheduled to take place from 28 September 2024 to 13 October 2024 ("Tournament Period").</p> <p>The Contest is open to participants who are residents of Singapore, Malaysia, Indonesia, Thailand, Philippines, Vietnam, Australia and New Zealand and aged 18 years and above as stated on their Identity Card/ Passport (as of 28 September 2024). No payment of money is required to take part in the Contest. A Contest participant does not need to be a Tournament player.</p>
