

## SAMSUNG ODYSSEY CUP DOTA 2 CHAMPIONSHIP 2024: DOTA 2 TOURNAMENT TERMS AND CONDITIONS

- Samsung Odyssey Cup Dota 2 Championship 2024: Dota 2 Tournament (“**Tournament**”) is organised by Samsung Asia Pte. Ltd. of 30 Pasir Panjang Road Mapletree Business City #17-31/32 Singapore 117440 (“Samsung”).

The Tournament is open to participants who are residents of Singapore, Malaysia, Indonesia, Philippines, Vietnam, Thailand, Australia, and New Zealand and aged 18 and above as stated on their Identity Card/Passport (as of August 1, 2024) (“Participant(s)”).

Each Participant shall maintain an active and valid Steam gaming account, free from any bans, suspensions, or other punitive restrictions imposed by the game’s administrators.
- Employees and agents of the promoters of this Tournament (TGC Marketing Sdn. Bhd.) and Samsung and its affiliates, their respective families, households or anyone professionally connected with this Tournament (in Samsung’s opinion), are not eligible to enter this Tournament.
- By participating in this Tournament, each Participant agrees to be bound by these Terms and Conditions and Tournament Rules and Regulations on the Tournament website (URL: [odysseycup.gg](http://odysseycup.gg)). All rules and regulations and instructions issued by Samsung from time to time will be deemed incorporated in these Terms and Conditions.
- “Dota 2” is a trademark registered by Valve Corporation. This tournament is independently organized and is not endorsed by Valve Corporation unless explicitly stated.
- Participants shall conduct themselves in a manner consistent with the principles of sportsmanship and fair play. Conduct contrary to these principles, including but not limited to harassment, use of abusive language, and inappropriate behaviour, shall constitute grounds for immediate disqualification and potential future sanctions. Any disputes shall be addressed through appropriate channels and resolved in a manner that upholds respect and decorum.
- Samsung reserves the right, at its sole and absolute discretion at any time without assigning any reason, to amend these Terms and Conditions, including without limitation changing the Tournament mechanics, Tournament Period and/or substituting the prize(s) with other item(s). No person shall be entitled to, and Samsung shall not be liable for, any payment or compensation (whether in cash, credit or kind) whatsoever arising from the foregoing.
- The Tournament registration will commence on **1 August 2024 at 00.00am Singapore Time**, and close on **18 September 2024 at 23.59pm Singapore Time** (“**Tournament Period**”).

Entries will only qualify for the Tournament if submitted within the Tournament Period as shown on the date/ time-stamp of the Entry on the Tournament website (URL: [odysseycup.gg](http://odysseycup.gg)) (“**Tournament Website**”). Entries submitted outside of the Tournament Period, or submitted through any means other than specified herein, will not be eligible for the Tournament. Each entry must be submitted by a complete team with a minimum of five players to be eligible for the Tournament. Any complaints on missing, incomplete team and/or delayed submissions will not be entertained.
- Samsung makes no guarantee of the availability of its or any other web services and will not be held responsible for any interruption, delay or failure of service that may interfere with the ability to participate in the Tournament.

9.	<p><b><u>TOURNAMENT MECHANICS</u></b></p> <p>The Tournament shall comprise 3 components:  Phase 1: Open Qualifier  Phase 2: SEA Finals (Southeast Asia + 4 invited professional teams)  Phase 3: Grand Finals (Southeast Asia + Oceania teams)</p>
10.	<p><b><u>TOURNAMENT PLAYOFFS</u></b></p> <p>Open Qualifiers will be conducted by each participating country, Malaysia, Singapore, Indonesia, Philippines, Thailand, and Vietnam which categorise under the Southeast Asia (SEA) region and we have Australia and New Zealand that categorise under the OCEANIA (OC) region.</p> <p>The Open Qualifiers will follow a single-elimination tournament format, with 6 slots from SEA qualifier advancing to the SEA Finals and 2 slots from OC qualifier advancing to the playoffs.</p> <p>In the SEA Finals, 12 teams with 4 invited professional teams will compete in a round-robin tournament format. The top six teams will then progress to the Grand Finals.</p> <p>The Grand Finals will feature a total of 8 teams, with six teams from Southeast Asia and two teams from Oceania. The tournament will follow a double-elimination format</p>
11.	<p>Prizes are not exchangeable by the winner(s) for other items, and are not transferable.</p>
12.	<p><b><u>PRIZES</u></b></p> <p>Total Prize pool: USD 20,000</p> <p>CHAMPION: USD 8,000 cash per team  2<sup>nd</sup> Place: USD 4,000 cash per team  3<sup>rd</sup> Place: USD 3,000 cash per team  4<sup>th</sup> Place: USD 1,500 cash per team  5<sup>th</sup> Place: USD 1,000 cash per team  6<sup>th</sup> Place: USD 1,000 cash per team  7<sup>th</sup> Place: USD 750 cash per team  8<sup>th</sup> Place: USD 750 cash per team</p>
13.	<p>The winning team(s) shall appoint a representative, whom shall be required to present his/her identity card/ passport for verification purposes. If a winning team requires a proxy to collect the prize(s) on their behalf, a photocopy of the winning team's representative's identity card/ passport, an authorisation letter stating the authorisation for the proxy to collect the prize(s) on their behalf and duly signed by the winning team's representative, and the proxy's identity card/ passport, must be presented by the proxy for verification purposes. 22.	<p>To the fullest extent permissible under applicable law, Samsung (including its officers, employees and agents) excludes all liability (including for negligence), for any personal injury, or any loss or damage (including loss of opportunity), whether direct, indirect, special or consequential, arising in any way out of the Tournament, including but not limited to, where arising out of the following: (i) any technical difficulties or equipment malfunction (whether or not under Samsung's control); (ii) any theft, unauthorised access or third party interference; (iii) any Entry, claim or prize that is late, lost, altered, damaged or misdirected (whether or not after receipt by Samsung) due to any reason beyond the reasonable control of Samsung; (iv) any variation to the prize(s) value from that stated in these Terms and Conditions; (v) any tax liability incurred by Participant(s); or (vi) use of the prize(s). By participating, all contestants agree to release, indemnify, and hold harmless Samsung and its affiliates from any claims, losses, damages, or liabilities arising out of their participation in the tournament.</p>
24.	<p>Except where expressly provided herein, each Participant shall bear his/her own taxes, costs and expenses incurred and/or arising from his/her participation in the Tournament, and no reimbursement may be sought from Samsung.</p>
25.	<p>In the event of any dispute arising from the Tournament or relating to the interpretation of these Terms and Conditions, the decision of Samsung shall be final and binding on all parties. No correspondence, appeal or further claims will be entertained.</p>

26.	These Terms and Conditions shall be governed and construed in accordance with the laws of Singapore, and each Participant irrevocably submits to the non-exclusive jurisdiction of the courts of Singapore.
